By booking and attending this retreat, you agree to the following terms and conditions:

#### 1. Price

The retreat price includes accommodations, meals, tuition, and other specified inclusions. and are based on costs and exchange rates at the time the itinerary was prepared. Prices do not include airfare, travel insurance, visas, personal expenses, or additional activities unless explicitly stated. Full payment is required before attendance, as per the payment schedule provided. We reserve the right to adjust prices should there be significant fluctuations in exchange rates, supplier or operational expenses.

# 2. Assumption of Risk

# 3. Exclusion of Liability
